Efforts will be made to accommodate the candidates in the preferred centre based on the availability of necessary infrastructure. In case of inability to consider their preference, other test centre will be allotted. If required, the management may conduct the Aptitude Test at districts other than the districts noted above. **Preference of the test centre exercised by the applicants shall not confer any right for allotment of the same.** The candidate will have to appear for the Aptitude Test at the allotted centre and venue only. Any request for change of centre will not be entertained.
- vi) List of eligible candidates for the online Aptitude Test along with other details viz., date, time & venue will be published in KPTCL/ESCOMs Web Site at a later date.
- vii) The candidates will have to appear for the Aptitude Test at their own cost.

### 11. GENERAL INSTRUCTIONS:

- (i) No person who has been convicted of an offence involving moral turpitude or who has been temporarily debarred or disqualified by the Union or any State Public Service Commission from appearing for Examination or Selections conducted by it shall ordinarily be appointed unless the Company after review of all the circumstances considers him/her suitable for such appointment.
- (ii) Applications with false information are liable to be rejected. Candidates who obtain appointment by furnishing false information in the application are liable to be terminated and criminal procedure will be initiated in accordance with law.
- (iii) All correspondence (either through post or e-mail or SMS) will be made against the details furnished in the application. **Correspondence for change of address, e-mail & mobile number at a later date will not be entertained.**
- (iv) Candidates claiming Caste/Category reservation will have to produce certificate in the **prescribed format only (Formats in any other form cannot be considered)** as and when called for. The details of formats are as below:

- (v) The formats of the certificates are available in KPTCL Website.
- (vi) Candidates claiming Caste/Category/ other reservations have to produce following certificates in the prescribed format as per orders/guidelines of Govt. of Karnataka. **The candidates should be in possession of valid certificates on or before the last date fixed for submission of online application.**
- (vii) Candidates are expected to know the criteria for claiming reservation under SC, ST, Category- I, IIA, IIB, IIIA, IIIB, reservation as well as norms for horizontal reservation under each quota prevailing in Government of Karnataka as on the last date prescribed for submission of application.
- (viii) The decision of KPTCL & ESCOMs in matters relating to eligibility of the candidates will be final and binding.
- (ix) Canvassing in any form for appointment will be a disqualification.

General Merit candidates claiming reservation under rural quota shall also produce certificate in **Form-1** certifying that they do not fall under the creamy layer prescribed by Government of Karnataka.
- b. Ex-Military Personnel** Should possess Discharge Certificate for having served in Military/Defence/Armed Forces.
- c. Kannada Medium Study Certificate** Certificate for having studied in Kannada Medium from 1<sup>st</sup> Standard to 10<sup>th</sup> Standard as prescribed in GoK Notification No: DPAR 71 GPR 2001 dated 24.10.2002 duly countersigned by the concerned BEO.
- d. Project Displacement Quota** The candidates should possess certificate issued by the Competent Authority for having lost their Agricultural Land/Residence for projects.
- e. Physically Handicapped** Should possess a medical certificate issued by the competent medical authority to show physical defect or deformity to an extent of minimum **40%**. The nature of disability notified for the particular posts only will be considered.
- (x) The candidate shall furnish valid e-mail ID and mobile number/contact number for future communication in the online application.
- (xi) Original documents/testimonials/certificates/records etc., shall be produced for verification only when called for.
- (xii) The candidates who are in Government service shall submit a 'No Objection Certificate' in original, from their employer at the time of document verification failing which their application will be rejected.
